# Monthly MVA Treasurer's Report presented by Eric S

MVA has upgraded its accounting software. It purchased new software that is connected to bank reporting, taxes, etc. that provides better traceability. Currently MVA has \$41,000 in the bank with \$33,000 of that in the general fund and the rest in grant money. The pending Pocket Park sign spending cleared out of grant money. Our primary sources of income are household and business memberships. Expenditures this month included accounting software, marketing, pot luck supplies and coded locks for the MVA Info Center.

# Merion Village Block Watch Update presented by Mary Cannon

919 S High ST. South Wind Motel has doubled in calls so officers are addressing concerns. Mary is still looking for a new block watch coordinator.

# 1385 S. 5<sup>th</sup> St. Zone Variance Vote presented by Tony R and Julie

The request is to break a double lot into two separate lots. The owner had the option to add on or make the house a duplex without any variances, but would like to add an additional single family home in scale with other homes in the neighborhood (approx.. 1800-2,000 sq. ft.) with a two-car attached garage. He also plans to renovate and add a garage to the existing house. He will then sell both houses. The new build will potentially have an asking price of between \$250,000-\$300,000. Area neighbors had complaints about how the initial rehab was messy. They had concerns about the following: proximity to neighboring houses, foundational disturbances, drainage, construction length and noise. 55 nearby neighbors signed a petition against the variance. Voting results: 12 support, 5 oppose, 1 abstain.

## Neighborhood Conservancy presented by Tom Les

Would like to make a motion next MVA meeting by selecting a contiguous shape and size portion of the neighborhood to begin the process. 60% of the people living in that section must approve. It was mentioned to potentially choose the section with the most members of the association. One the signatures of those residents are collected, the application goes to the city with a 6-9 month review process. The board supports this move and whiles it does not include restrictions on residents, it would give leverage to the city to do things like keep trees and bricks and provide other clean up and safety initiatives.

#### **Guest Speaker Maryhaven** presented by Lanon

The new stabilization center on S. High opened on January 19<sup>th</sup>. They have hired Dr. Devin from Ohio Health as their Director of Medicine. 41 people have been brought to the facility so far. 10 are in detox; 10 are in residential treatment; 1 is in triage; 6 have been transported to other long-term care facilities, and the rest have chosen to leave before going through the entire program (6 against medical advice.) The facility has bed for 55 people: 5-7 triage, 20 detox, and 30 residential. Every person released has been transported and there have been no issues requiring police intervention. One success story: on the very first day, the first person admitted wanted to leave, but with peer mentors, he/she ended up going through detox and residential programs. Their request from community members is donations of motivational/inspirational books or DVDs.
